The total aggregate number of shares shorted in the past 7 months is approximately 33.84 million shares (3:1 split adjusted). The SqueezeTrigger price for all shares shorted is \$17.18. A significant short squeeze is just now beginning as shares of EBIX closed at \$17.23 on Friday. The total short interest (shares still uncovered) as of February 26, 2010 is 9.99 million shares. There is \$172.25 million worth of short covering that still needs to take place.

Friction Factor is used to calculate if a fair market is being made in the shares of EBIX. 48% of the previous 33 trading days are positive or bullish-biased and 52% of the trading days are negative or bearish-biased. BUYINS.NET will monitor EBIX market makers daily for compliance with Fair Market-Making Requirements. Friction determines how many more shares of buying vs. selling it takes to move EBIX higher/lower by 1 cent.
